Students will work to create proposals about how to improve the California public education system and then

- present those ideas to the State Board of Education. She asked the Student Board Members to contact the Superintendent's Office if they are interested in attending.
- She announced that Pioneer High School is inviting two Board Members to volunteer to judge the homecoming floats the following Friday, October 21st. Trustees Pyeatt and Tafoya volunteered to be float judges.
- She thanked Dingle ES, Freeman ES, and Beamer ES for participating in the elementary track meet that day at Maxwell ES. She also thanked the staff for supporting these fun and healthy activities for students.
- She thanked everyone that attended the Groundbreaking event for the new school in the Spring Lake area the previous Tuesday.
- She thanked staff, particularly principals, for working through the MTSS framework and establishing a foundation for leaders in continuous development toward cultural proficiency.
- She announced that the 17th Annual Murder in the Library event titled "Water Main" will be held on Saturday, October 22nd at 6:00 p.m. at the Woodland Public Library. She shared that it is her 2nd year in character for this community fundraiser, and she invited everyone to attend the event.

Cache Creek High School Student Board Member Alenna Roberts reported that on September 27th the Superintendent Community Forum #1 was held for Cache Creek HS and Sci-Tech Charter School, and it was well attended. On September 28th, Counselor Mrs. Elaine Cummings invited two schools to present to the classes: Universal Technical Institute and the National Holistic Institute. On October 4th, Woodland Community College was on campus to do presentation on college programs, certificate programs, and share general information. On October 5th, a dedication was held for the new office space in room 13 that was funded by the Woodland Rotary Club. October 14th is the end of the 1st quarter, and students will receive grades on Monday, October 17th. Students Clarissa Corona and Diana Valencia-Villaneuva will begin an internship at Yolo County Head Start. She thanked Andrew Codd, the Internship Specialist for the College and Career Readiness program at the Yolo County Office of Education, for coordinating the internship opportunity. She shared that School Custodian Maria Morales lost a family member in a tragic car accident. All the students and staff are deeply saddened. The art classes are creating hearts with messages to post for Mrs. Morales upon her return. She asked everyone to send condolences and prayers for her and her family, as one of her grandchildren is still hospitalized. She shared that Cache Creek students strive to be Positive, Present, and Productive. When students demonstrate these qualities, they are given a CLAW to put in a box for a weekly drawing to acknowledge being successful.

Pioneer High School Alternate Student Board Member Malika Sen reported that Homecoming Week starts the following week, and Disney is the theme. Spirit days are set, as well as a rally on Thursday and a Homecoming Dance on Saturday. ASB is busy planning all the Homecoming events. Their annual Shopping Cart Parade will also be held the following week. Over 20 clubs are participating by building floats using shopping carts that incorporate the Homecoming theme and the club's message. The Homecoming football game will be held on Friday, October 21st against the Yuba City Honkers. Float building for the Homecoming game starts the following day. Jazz Band held their first concert the previous day and it was well attended. The Spring Musical has been selected, and it is "Tarzan the Musical." Auditions will be held in December. The San Francisco Jazz Collective will be at Pioneer HS on Friday after school, and the Advanced Jazz Band will get a 1-hour clinic with the musicians. She stated that they are famous musicians, and they are lucky to have them visit, thanks to Music Teacher Bobby Rogers.

Woodland High School Alternate Student Board Member Tiara Cardenas reported that they are preparing for Homecoming Week, and their theme is "Woodland Got Game," which is inspired by board games. Each class decided on a board game to represent them, and it is a great way to show their school spirit and unity. Homecoming Week is October 24 - October 28, and the Homecoming football game is on Friday, October 28th against River City Raiders. The Homecoming Dance is on October 29th. Powderpuff

teams have started to practice, and they are preparing for their upcoming games during Homecoming Week. The students and community are anxiously awaiting the outcome of the update on the bleachers. They are excited to see their stadium become theirs again. ASB Students attended the annual CADA Conference on Tuesday October 4th. The Woodland Police Department trained WHS staff on what to do when an active shooter is on campus. They honored their student heroes on October 6th with a Pizza Party. FFA hosted a field trip to the Dixon Com Maze on October 11th, and it was well attended. FFA hosted their Drive Thru Tri-tip BBQ Dinner on Wednesday October 12th. They held a Pink Game in honor of breast cancer victims on Friday, October 7th during their football games. Their Cross Country Team also participated in Pink Month. ASB is selling pink breast cancer awareness t-shirts, and proceeds will be donated to breast cancer research. La Semilla is hosting a movie night on Friday, October 14th. Counselors are preparing students for the PSAT's on Wednesday, October 19th, by passing out the PSAT practice book to the students that signed up. English Teachers attended a conference regarding close reading, and they returned with exciting ideas.

As the bid did not meet the minimum conforming price, Ms. Allred continued with the oral auction. As no one participated in the oral auction, the public auction was closed.
