# June 3, 2021 Public Comments

Dear WJUSD School Board and WJUSD

Administration, I will keep this brief.

I estimate that I have worked 300-340 hours of uncompensated overtime this school year, and my guess is that that number is similar for many, if not most, of the teachers in this district. Multiple that by the \$42 hourly rate, and you get between \$12,600 and \$14,280. The paltry \$1000 stipend you are offering is insulting to the incredible teachers and staff who have made this school year possible.

Recently, our neighboring DJUSD School Board voted unanimously to give their district employees a \$2500 stipend in recognition of their extra labor during the pandemic. While this undoubtedly does not nearly compensate people for the extra hours they worked, it does represent a bit of support and gratitude not felt here at WJUSD.

I urge you to recognize the work we have done this year and to compensate us appropriately. Thank you for your consideration, Lisa Gaskill
