## **Public Comments Submitted Via Email**

Dear Trustees, Superintendent Lampkin and Associate Superintendent Wiley:

These comments are my own and in no way reflect the opinions of the District Community Bond Oversight Committee.

I have been intimately involved in the development of the Facility Master Plan and have found the process developed by LPA and their partners to be excellent and illuminating. The facility needs in the District are eye-poppingly large and it's important our community understand where the District needs community support. The FMP will go a long way towards that understanding.

I am concerned about the summary at the end of the document (page 59), where some "flagship" project priorities are presented. "Curb appeal" and the (fully functional) WHS stadium have high priority but lunch shelters (strongly favored by students and staff) and a second gym at Pioneer High (an equity and safety issue) are listed with a much lower priority. I don't understand this logic.

Additionally, a "flagship CTE project at WHS" isn't mentioned or described in any of the previous 58 pages of narrative. What is this project? How much does it cost?

It appears from the narrative - specifically pages 49-51 - a list of projects of immediate need, directly affecting safety of students and staff or mission critical systems, is presented. At \$4.6M, I strongly recommend consideration of these projects at the highest priority. These projects could become "flagship" projects with good public relations to the community.

Thank you for supporting development of the Facility Master Plan. As the District discusses future facility bond opportunities, this will be a critical piece of those discussions.
