I served as the Maintenance POC for the school during the 3 years that Sofia attended the school. I personally feel very proud and accomplished on all the projects we help the school accomplished. Occasionally if we happen to drive by school, many good memories come to mind, good things happened at this school. My wife and I learned the power of being involved with your children's education. WPNS showed us this power and the many positive retributions we get when parents are involved. We have continued with this involvement when Sofia transitioned into Elementary and Middle school. Dear Distinguished Board Members,

When my children and I first walked through the little rainbow gate and in the front door of Woodland Parent Nursery School I knew we had found the right place for us. We were embraced by a loving group of people, many of whom are still in our lives today. The very best part of my experience at WPNS was the educational component that helped me navigate parenting two preschoolers and help guide them through adolescence and into young adulthood. Parenting doesn't come with a manual and I was definitely not a natural - I needed to learn and I truly got an incredible education at WPNS.

I now work for WJUSD and, I assure you, I would never have considered working with children had it not been for that preschool. Teacher Debbie helped show me the importance of connecting with children at their level, learning with them, playing with them, cooking with them, making messes with them, cleaning with them! She showed me the importance of being a partner in my child's education. WPNS taught me that an engaged parent produces an engaged student. I have remained very much a part of my children's education even as my youngest enters their final year of high school. I see the same with many former WPNS families. Both of my children have remained close with their preschool friends and we still socialize with many families. I count the parents I met in those years among my closest and most treasured friends.

I work at SciTech and I can always spot a WPNS parent. They are the ones who volunteer for PTO, they are the ones volunteering in classrooms, they are the ones chaperoning field trips, and they are the ones jumping in to help at our fundraising events.

Closing WPNS feels like a disservice to our community. It's a small part of what makes Woodland unique and special. It's my hope that the School Board will reconsider their decision to close this very
