Dear Superintendent Ortega-Lampkin, President Villagrana, and Trustees,

This is regarding agenda item G.a.

#17(https://simbli.eboardsolutions.com//SU/bKpQZBBDShYgslshd10ZhDxhQ==), which is \$65,000 for teacher collaboration training at Douglass and Lee middle schools.

We strongly support efforts to improve teacher collective efficacy because it is the single most important quality leading to improved student outcomes. John Hattie, internationally renowned education research has shown it has an effective size of SDS = 1.45.

We acknowledge that our comments/questions are limited to just the documents provided by the Board Agenda which includes the resolution and the Quote, we are concerned that the information provided to the Board members does not include any indication of how the success of this initiative will be determined.

We have the following questions.

- 1. How will the project determine the degree to which teaching methods arising from this effort are being implemented, not just while the funding is in place, but later as well? A robust approach we would urge the project to consider adapting to this project is shown in the following example(https://simbli.eboardsolutions.com//SU/SFv89sQ70tg9wplusageirg3g==).
- 2. According to the resolution, "Many students enter middle school significantly below grade level and we only have two years with our students to get them ready for the rigor of high school mathematics classes." Given this, wouldn't it make more sense financially and from student experience perspective to shift resources to the primary grades, so the problem can be resolved at its source? There are many districts who serve students like ours that don't have this issue.
- 3. Principals are traditionally the primary position to support good teaching on an ongoing basis. Does this indicate there is a misalignment of staffing which is inhibiting the full exercise of the principal's traditional role as a teaching coach?

Than you, Clara Olmedo Hello Superintendent Ortega-Lampkin, President Villagrana, and Board Members, My name is Brian Coward. I'm a father, husband, Woodland resident, and member of the Woodland Accountablility Community group. I am here once again to bring to the attention of my District and Board of Trustees the terrible inequity being placed upon Woodlanders and the sum 880 Spring Lake children that do not have access to a neighborhood school. This District made an agreement with Woodland residents and the Spring Lake developers to provide two schools, each with a capacity of 650 students. Spring Lake is nearly complete. We have a single school, Spring Lake Elementary, with an anemic student capacity of 420.

Tonight the District is recommending approval of item L.2. Updated Annual and Five-Year Reportable Fees Report for 2021-22. The report highlights that the District is wasting \$75,633 annually on portables, a new elementary school is projected to cost \$49,557,484 million (\$24,664,760 / 0.4977 of an elementary school), that the fees are collected with the purpose of building .49 of an elementary school and .20 of a high school, that in five years the fees are projected to total \$2,709,611, and that Fund 27 and 28 are not reportable fees. The DFA expressly states the desire to remove portables from use which demonstrates the poor management and planning for Fund 25. The projected costs for an elementary school should inform the Board that Fund 25 will not attain its mitigation goals independently of Fund 27 or 28 and that geographically it makes sense to use these funds to build a school where it is needed, in the Tech Park development. Finally, the suggestion that Fund 27 and 28 are not reportable is propostourious and morally bankrupt. Those funds have had annual reports produced. Why would they be exempt from the five year reports? Demand the District produce five year reports for those funds too.

Finally, this Board needs to step up. Which Trustee on this Board will hold to their responsibility; setting direction, establishing an effective and efficient structure, providing support, ensuring accountability, providing community leadership as advocates for children, the school district and public schools? Request a Future Agenda Item to amend the DFA to include a new elementary school in the Tech Park! Hold the District accountable for the 880 Woodland children that don't have a school.

Hola superintendente Ortega-Lampkin, presidente Villagrana y miembros de la junta, Mi nombre es Brian Cobarde. Soy padre, esposo, residente de Woodland y miembro del grupo Woodland Accountablility Community. Estoy aquí una vez más para llamar la atención de mi Distrito y la Junta Directiva sobre la terrible inequidad que se impone a los Woodlanders y la suma de 880 niños de Spring Lake que no tienen acceso a una escuela del vecindario. Este Distrito hizo un acuerdo con los residentes de Woodland y los desarrolladores de Spring Lake para proporcionar dos escuelas, cada una con una capacidad de 650 estudiantes. Spring Lake está casi completo. Tenemos una sola escuela, Spring Lake Elementary, con una capacidad de 420 estudiantes anémicos.

Esta noche el Distrito recomienda la aprobación del artículo L.2. Informe actualizado de tarifas reportables anuales y quinquenales para 2021-22. El informe destaca que el Distrito está desperdiciando \$75,633 anualmente en portátiles, se proyecta que una nueva escuela primaria costará \$49,557,484 millones (\$24,664,760 / 0.4977 de una escuela primaria), que las tarifas se recaudan con el propósito de construir .49 de una escuela primaria y .20 de una escuela secundaria, que en cinco años las cuotas se proyectan en un total de \$2,709,611, y que los Fondos 27 y 28 no son cuotas declarables. La DFA declara expresamente el deseo de dejar de usar los portátiles, lo que demuestra la mala administración y planificación del Fondo 25. Los costos proyectados para una escuela primaria deben informar a la Junta que el Fondo 25 no alcanzará sus objetivos de mitigación

independientemente del Fondo 27 o 28 y que geográficamente tiene sentido usar estos fondos para construir una escuela donde se necesita, en el desarrollo del Tech Park. Finalmente, la sugerencia de que los Fondos 27 y 28 no son reportables es propostural y moralmente en bancarrota. Esos fondos han tenido informes anuales producidos. ¿Por qué estarían exentos de los informes quinquenales? Exija que el Distrito produzca informes de cinco años para esos fondos también.

Finalmente, esta Junta necesita dar un paso al frente. Cual Fideicomisario en esta Junta mantendrá su responsabilidad; establecer dirección, establecer una estructura eficaz y eficiente, brindar apoyo, garantizar la rendición de cuentas, proporcionar liderazgo comunitario como defensores de los niños, el distrito escolar y las escuelas públicas? ¡Solicite un Punto de Agenda Futura para enmendar el DFA para incluir una nueva escuela primaria en el Parque Tecnológico! Responsabilizar al Distrito por los 880 niños de Woodland que no tienen escuela.

Dear Superintendent Ortega-Lampkin, President Villagrana, and Trustees,

We are writing in the strongest possible support of Trustee MacDonald's and Trustee Rodriguez's request to establish a path to improve the academic performance of our schools with the expectation that students will achieve a 3.0 GPA or higher and meet or exceed all state standards. This may seem like a "moon-landing" kind of ambition. It is not! As discussed below, Goal 3.0 GPA is something other public school systems have already achieved with students from the same socioeconomic position as ours. The first step in any decisive and bold effort is to believe deeply that its success is possible. This belief should be easy because other schools like ours are already doing it. 93% of Dingle Parents Expect Scholars to Continue Education Post High-School In our recent 2023 parent survey at Dingle, 93% of respondents (76% of Dingle's households) said they expect their scholars to continue education after high-school (college, trade school, professional license, etc.). This % was consistent across English Language Learners, Dual-Immersion, and Non-Dual-Immersion families.

3.0 GPA (B letter grade) Required for College Admissions

A scholar must have a 3.0 GPA or higher to be accepted into a regional California State University as a Freshman. A scholar should aim for a 4.0 GPA or higher and take AP courses to be accepted into a regional University of California campus.

Thank you Trustee MacDonald and Trustee Rodriguez for Expecting 3.0 GPA or Higher A.S.A.P. In prior WJUSD Board of Trustees meetings we heard Trustee MacDonald and Trustee Rodriguez express concern about the current academic performance of Woodland scholars, particularly the majority socio-economically disadvantaged population, and asking for a path to improve academics as quickly as possible. Dingle families fully support these expectations, thank you!

Thank you WJUSD staff and all of those that worked on the Graduate Profile Update. It looks like a lot of care was put into it. The profile is aspirational.
