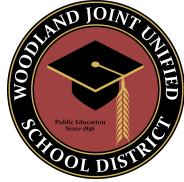

March 28, 2024, Regular Meeting Summary

At the March 28, 2024, Regular Meeting, the Board:

- Approved a Board resolution in support of [National Vietnam War Veterans Day](#). Trustee Bibiana Garcia presented the resolution to local Vietnam War Veteran Eloy Garcia.
- Approved a Board resolution in support of [Cesar Chavez Estrada Day](#). President Rogelio Villagrana presented the resolution to our High School Student Representatives to the Board Jayden Gortarez (Cache Creek High School), Liliana Sepulveda (Pioneer High School), and Mahad Naeem (Woodland High School).
- Approved a Board resolution in support of [Child Abuse Prevention Month](#). Trustee Kandice Richardson Fowler presented the resolution to Child Abuse Prevention Council Coordinator Guadalupe Lugo, and Executive Director Jeneba Lahai from the Yolo County Children's Alliance.
- Approved a Board resolution in support of [Dolores Huerta Day](#). Vice President Deborah Bautista Zavala presented the resolution to CSEA President Rebecca Rossiter and WEA President Becca Bernard.
- Recognized Pioneer and Woodland high school students and teachers for winning creative writing awards in the “Voces de Sacramento” writing contest. For Pioneer High School, students include Mildred Victoria Saldaña (first place), María Jaime Hernández (second place), and Melanie Salazar (honorable mention). For Woodland High School, student Alejandra Vargas Reyes won honorable mention. Teachers from both schools also entered the contest and won awards in the adult categories, including Jaime Rocha from Woodland High School (honorable mention) and Delia Zamudio from Pioneer High School (second place).

- Reviewed the [Process](#) and Timeline to Fill the Board Vacancy for Trustee Area 2. The Board discussed the [timeline for holding an election](#) and the [timeline for appointing](#) someone to fill the vacancy. The Board gave direction to staff to prepare an agenda item with a resolution for the April 25, 2024 board meeting to order an election to fill the vacancy for Trustee Area 2.
- Reviewed a [staff Update on Social Emotional Support for Students](#).
- Approved the Kindergarten through Twelfth Grade Science Adoption. On March 14, 2024, staff presented an update on the science textbook pilot that teachers and students engaged in this school year. The programs selected and approved for purchase are TWIG for grades K - 5; Amplify for grades 6 - 8; and Savvas for grades 9 - 12.
- Reviewed a presentation of the Measure Y G.O. Bond [Performance Audit & Financial Audit](#) from Crowe LLP.
- Reviewed a [Presentation of Polling Survey Results](#) from Dale Scott & CO. In March 2023, the Board approved Dale Scott & CO to survey registered voters about attitudes toward a new bond measure, specific projects, and tax rates.
- Discussed a [Resolution Ordering an Election to Authorize the Issuance of School Bonds, Establishing Specifications of the Election Order, and Requesting Consolidation with Other Elections Occurring on November 5, 2024](#) to fund important school facility improvement needs. The Board voted to table a vote on this item until the May 9 Board Meeting.
