Woodland Youth Plan Development Process

PHASE 1

Included:

- Identified district and community representatives to comprise Leadership Committee
- 6 hour professional development session on Youth Development 101 and Youth Engagement Strategies
- 6 hours of Dynamic Meetings for 15 Leadership Committee leaders and their departmental teams (about 50 people attended) to lay foundation for the work and outline the process
- Youth Development Network (YDN) facilitated a Youth Engagement survey and analyzed/summarized the results to share wit the Leadership Committee.

PHASE 2

Included:

- YDN facilitated Listening circles:
 - Middle and high school students
 - Middle and high school parents
 - Special education parents
- YDN collected feedback from listening circles and shared with Leadership Committee
- Planned work group sessions to develop the WYP

Included:

- Six 90-min monthly exec leadership meetings

Accountability requirements

Districts are required to:

Highlights from March Update

- 360 students are projected to be CTE pathway completers, with
 6 students at Cache Creek High School for the first time
- Pathway awards for Biliteracy have been created and 100 students will receive this award in Spring 2023

Challenges

• Our a-g completion rate improved very slightly from 2021 (.9%)

Goal 2: Meet Social-Emotional and Academic Needs

Highlights

- English Learners made growth of 5.8% on the English Learner Progress Indicator
- 146 small groups have been offered to provide students with social emotional supports

Challenges

• Scores on the Smarter Balanced summative assessment declined from 2019 by >5% for ELA and >3% for math

Goal 3: Accelerate English Learner Achievement

Highlights

- Federal PROMESA grant is providing professional development for teachers and training for parents on dual immersion as a highly effective model of instruction for English Learners
- English Learners made 5.8% growth on the English Learner Progress Indicator
- The number of Long Term English Learners at secondary schools has decreased

Challenges

• English Learner performance on Smarter Balanced is Very Low in English Language Arts and Math

- The district has established a partnership with the Native Dads Network to provide cultural programming for Native American students
- All school sites have active Youth Advisory Committees
